With the rain and the mild winter that we are experiencing so far and in the areas that were not burnt, I think we could be in for a good season. I have noticed some Blue Gum and Paper Bark flowering recently, and some stringy bark on the Tablelands as well.

This is the time of year to prepare for the Spring. Make/repair your boxes, frames, nucs etc. Don't put the foundation wax on until you are close to using the frames. This will save them from wax moth attack.

The members who sold honey through the Club bulk collection system should be happy with price of \$6 and \$14.50 for the higher Manuka Factor tested honey per kg.

I think the collection and sale of our surplus bulk honey is generally a good idea. However, there have been a few hassles so we need to review the practicalities of the system if we are to continue. Many thanks to Matt for taking charge and administrating the system.

I have checked approximately 60 hives in recent times with various amateur beekeepers. Many hives were going well, with healthy, well populated hives with good stores. You may also be interested in some of the other things that I found: No queen? – often not correct as they may reduce or may stop laying over winter; some starving; one a bit aggressive - bees were a different colour to the other hives so suspect they had requeened themselves at some stage; a few dead outs – possibly starved or diseased; excessive moisture; a few small hive beetles; one suspected AFB; some wax moths.

Changes to Beekeeper registration from 1st July 2020

By now all registered beekeepers in NSW would have received a letter outlining these changes.

A new condition will come into effect 1 July 2020 requiring existing and new beekeepers registered in NSW to comply with the Australian Honey Bee industry Biosecurity Code of Practice.

The Australian Honey Bee Industry Biosecurity Code of Practice (the Code) has been developed by industry in collaboration with all states and territories to provide a national minimum standard for beekeeping practices. From 1 July 2020, it will be compulsory for beekeepers registered in NSW to ensure their management practices meet the minimum standards outlined in the Code.

Meeting these standards will not be a big change for beekeepers who have already adopted sound management practices in their beekeeping and comply with current requirements under the NSW Biosecurity Act 2015.

The Code is divided into parts. Part B of the Code is compulsory for all beekeepers. Part C applies only to beekeepers managing 50 hives or more. Part D is recommended, but not compulsory. A summary of new and existing requirements is available on the NSW DPI registration webpage.

It is the responsibility of all beekeepers to make sure they are complying with all relevant parts of the Code prior to 1 July 2020 to avoid possible penalties following this date

Changes for under 50 hives.

- * Hives must be regularly inspected for pests and diseases. 3 brood inspections a year with record keeping.
- * Records must be kept for pest, disease inspection and sampling.
- * Recommendation(but not enforceable) for beekeepers to maintain a barrier system of hive management.

FRANK'S HIVE HINTS No 6

Sit in the sun and watch your bees as this is the time to make some pre-spring observations.

- 1) Pollen being collected by bees is a good sign that the queen is present and laying. Nectar being carried by heavily landing bees indicates that forage is available Water needs to be accessible in all seasons
- 2) If a hive has died out, examine it to find the cause.
- a. Starvation. Dead bees have their heads in the cells and there are no stores in the hive.
- b. Disease. Try to identify the type- AFB, EFB, Chalkbrood, Etc., DVD's available from our library will help.
- c. Pests. Beetles and wax moths are likely to take over when the hive is deserted.
- Action. Close the hive entrance to avoid robbing or spread of disease. Dismantle and clean the hive.

Note any concerns about a particular hive and inspect when the weather permits.

Honey Collection

The honey sale to Hive and Wellness Australia (formerly Capilano) went ahead and all members who participated have been paid (and quite handsomely too). Congratulations to those who had the Manuka honey in the 4th drum.

Below is information from their newsletter about the brand.

You may have seen some negative comments about Capilano and Hive + Wellness across social media recently. These are misinformed articles being shared by a blogger called Kangaroo Court of Australia. To be clear, we are not owned by China and Capilano honey is not Chinese. No products on supermarket shelves packed by us, or our parent company, contain Chinese honey.

Blogger Shane Dowling, of "Kangaroo Court of Australia", has been staging a digital media campaign of negative, damaging comments aimed to defame and damage the Capilano brand. Our company has instigated, through the Supreme Court of New South Wales, defamation and injurious falsehood action aimed to prevent Shane Dowling (Kangaroo Court) from making these untrue and false claims as a last resort of action.
